#### 8.2 Exposure controls

### Appropriate engineering controls

# Eye and face protection

Avoid contact with eyes. Always use protective safety glasses with side-shields conforming to EN 166 (EU).

#### Skin protection

Avoid contact with skin and mucous membranes. Avoid prolonged or repeated contact with skin. Always use disposable chemical-resistant gloves conforming to EN 374 (EU) to handle the product. When only brief contact is expected, gloves with protection class 1 (breakthrough time > 10 min according to EN 374) are recommended.
