## Assay Data: Sample Type: Serum, plasma, tissue homogenates, cell lysates, cell culture supernatants and other biological fluids. Target Type: Antigen **Assay Principle:** This kit is based on sandwich enzyme-linked immuno-sorbent assay technology. An antibody is precoated onto a 96-well plate. Standards, test samples, and biotin-conjugated reagent are added to the wells and incubated. The HRP-conjugated reagent is then added, and the whole plate is incubated. Unbound conjugates are removed using wash buffer at each stage. TMB substrate is used to quantify the HRP enzymatic reaction. After TMB substrate is added, only wells that contain sufficient C5a will produce a blue coloured product, which then changes to yellow after adding the acidic stop solution. The intensity of the yellow colour is proportional to the C5a amount bound on the plate.
